SECTION I.

SHORT TITLE

This local law shall be cited as Local Law # 2 of 1995 of the Town of New Scotland.

SECTION II.

LEGISLATIVE FINDINGS

The Town of New Scotland is facing unprecedented growth and development. Current proposals include large scale residential development.

The Town of New Scotland Planning Board on May 10, 1994 approved a Comprehensive Land Use Plan, which identifies many valuable resources contained within the Town, which are threatened by rapid development. The current Zoning Law of the Town of New Scotland is, in many respects, inconsistent with the newly enacted Comprehensive Land Use Plan and the Town Board has,

therefore, assembled an ad hoc committee to study the current Zoning Law and recommend appropriate changes to the Town Board.

The Town Board has also established an ad hoc committee to review existing water districts, needs and sources and to recommend an economically feasible water plan for the Town.

On July 11, 1994 the Town Board passed Local Law # 2 of 1994 suspending certain large scale development within the Town for a period of six months pending study of amendments to the Town Zoning Law by the ad hoc committee. Local Law # 2 of 1994 was extended until April 13, 1995 by Local Law # 1 of 1995. A proposed new Zoning Law is currently being studied by the Town Board & Planning Board and a further extension of Local Law # 2 is necessary to enable them to complete that study.

While that study is being conducted, the Town's rural character, historic features, the Helderberg Escarpment and many other valuable resources are threatened by rapid development. The Town Board finds that significant development in the Town prior to the enactment of amendments to the Zoning Law may substantially reduce the effectiveness of such amendments and would lessen the ability of the Town Board to afford adequate facilities for the distribution of public services, comfort, convenience, public health and safety, and the general welfare of the citizens of the Town of New Scotland.

SECTION III.

EXTENSION

Except as specified below, all provisions of Local Law # 2 of 1994 of the Town of New Scotland are extended until July 13, 1995 or until the effective date of any new Zoning Law hereafter enacted by the Town Board, whichever is earlier. This extension shall not apply to those provisions of Local Law # 2 of 1994 which prohibit Town officials, boards, or commissions from accepting or considering certain requests for site plan approval and special use permits.

SECTION IV.

VALIDITY

The invalidity of any word, section, clause, paragraph, sentence, part of provision of this Local Law shall not affect the

validity of any other part of this Local Law which can be given effect without such invalid part or parts.

SECTION V.

REPEAL OF OTHER LAWS

All state statutes and local ordinances or laws in conflict with the provisions of this Local Law are hereby repealed to the extent necessary to give this Local Law full force and effect during its effective period. Specifically, all provisions of Town Law Sections 274-a, 274-b and 276 and Local Laws # 1 of 1993 and # 2 of 1993 of the Town of New Scotland which are inconsistent with the provisions hereof are superseded and suspended hereby.

SECTION VI.

EFFECTIVE DATE

The Law shall take effect immediately, as provided by the Law, upon filing with the Secretary of State and shall remain in force and effect until July 13, 1995 or until the effective date of any Zoning Law hereafter enacted by the New Scotland Town Board, whichever is earlier.

on 19. Such local law being subject to a permissive referendum and no valid petition requesting such referendum having been filed, said local law was deemed duly adopted on 19, in accordance with the applicable provisions of law.

\*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village or the supervisor of a town where such officer is vested with power to approve or veto local laws or ordinances.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. .... of 19..... of the City of..... having been submitted to referendum pursuant to the provisions of § 36 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special election held on ..... 19 ..... became operative.
