Local Law 1 of the Year 2011

A local law Amending the New Scotland Ethics Law.

Be it enacted by the Town Board of the Town of New Scotland as follows:

Section 1. Purpose.

On June 9, 2010 the New Scotland Town Board adopted the New Scotland Ethics Law (Local Law 4 of the year 2010). On August 31, 2010 the Town Board adopted Local Law 7 of 2010, which stayed the substantive provisions of the Ethics Law to January 1, 2011 in order to allow time for the Ethics Board to respond to requests for advisory opinions and for the Town Board to consider whether any amendments to the Ethics Law are in order. The purpose of this local law is to amend the Ethics Law by eliminating the provision therein making any violation thereof a Class A misdemeanor. The Town Board is of the opinion that criminal classifications are better left to provisions already contained within the Penal Law and the General Municipal Law.

Section 2. Amendment of Ethics Law.

Local Law 4 of the Year 2010, entitled "New Scotland Ethics Law," is hereby amended by deleting Subdivision D of Section 26 thereof.
