Section 1. Pursuant to the authority set forth in Section 467 of the Real Property Tax Law, the Town of New Scotland hereby exempts any Senior Citizen from having to file a Application for Real Property Tax Exemption annually whenever said senior citizen has filed and been granted for five (5) prior consecutive years, the tax exemption on the Assessment Roll in the Town of New Scotland.

Section 2. The Town Assessors of the Town of New Scotland shall and hereby is authorized to automatically grant said real property tax exemption to any qualified senior citizen, pursuant to this Local Law.

Section 3. This Local Law shall take effect on the 1st day of July, 1994, and upon the filing in the Office of the Secretary of State of the State of New York.
