A local law to increase the real property tax exemption for property owners
(Local Title)
in the Town of New Scotland who are at least 65 years of age.

Pursuant to Real Property Tax Law Section 467(3)(a) the following sliding scale exemption is adopted on assessed valuation for property owners who are at least 65 years of age, with the additional 5% exemption for 1999, plus medical/prescription drug expenses.

ANNUAL INCOME	% of EXEMPTION
Not more than \$19,500	50%
\$19,500 or more but less than \$20,500	45%
\$20,500 through \$21,499.99	40%
\$21,500 through \$22,499.99	35%
\$22,500 through \$23,399.99	30%
\$23,400 through \$24,299.99	25%
\$24,300 through \$25,199.99	20%
\$25,200 through \$26,099.00	15%
\$26,100 through \$26,999.99	10%
\$27,000 through \$27,899.99	5%

The income tax year immediately preceding the date of application for exemption is the base for annual income.
