#### Town of New Scotland

#### Local Law #1 of the year 2007

A local law extending Local Law #7 of 2006 for 6 months.

Be it enacted by the Town Board of the Town of New Scotland as follows:

#### SECTION I.

#### SHORT TITLE

This Local Law shall be cited as Local Law 1 of 2007 of the Town of New Scotland.

#### SECTION II.

#### <u>LEGISLATIVE FINDINGS</u>

The Town of New Scotland is facing unprecedented growth and development, particularly in the area of the Town zoned MDR and R-2. Current proposals include large scale residential development. To address this issue, the Town Board is studying changes to the zoning in the area in question.

While that study is being conducted, the Town's rural character, historic features, and many other valuable features, and many other valuable resources are threatened by rapid development. The Town Board finds that significant development in the MDR and R-2 zones, beyond that which is currently under review, prior to the enactment of

amendments to the Zoning Law may substantially reduce the effectiveness of such amendments and might lessen the ability of the Town Board to afford adequate facilities for the distribution of public services, comfort, convenience, public health and safety, and the general welfare of the citizens of the Town of New Scotland.

On September 13, 2006 the Town Board passed Local Law #7 of 2006, suspending certain large scale development in the MDR and R-2 zones for a period of 6 months, while the Town Board studied proposed amendments to the Town Zoning Law. That study has progressed, but is not yet finalized. Extension of Local Law #7 of 2006 is necessary to enable the Town Board to complete its study and consideration of proposed amendments to the Town Zoning Law.

SECTION III.

EXTENSION

Local Law #7 of 2006 of the Town of New Scotland is extended for a period of 6 months from the effective date of this Local Law, and all provisions thereof shall remain in effect until such time.

SECTION IV.

**VALIDITY** 

This invalidity of any word, section, clause, paragraph, sentence, part or provision of this Local Law shall not affect the validity of any other part of this Local Law which can be given effect without such invalid part or parts.

#### SECTION V.

### REPEAL OF OTHER LAWS

All local laws in conflict with provisions of this Local Law are hereby superseded and suspended for a period of six (6) months from the effective date of this Local Law and for any additional period that this Local Law is extended.

#### SECTION VI.

## **EFFECTIVE DATE**

This Local Law shall take effect immediately, as provided by law, upon filing with the Secretary of State and shall remain in force and effect for a period of six (6) months from its effective date and for any additional period for which it is extended by the Town Board of the Town of New Scotland.
