# Section 1 - Intent

The Town Board of the Town of New Scotland recognizes that the Town Clerk's Office and Dog Inspector's Office are responsible for the licensing and enforcement of licensing of dogs in the Town of New Scotland. It is necessary that the Town Board establish an annual local fee for a dog license.

#### Section 2 - Local Fee for Dog Licenses

The Town Board of the Town of New Scotland establishes a local fee of \$2.00 annually for each dog license issued, as permitted by Section 110, Subdivision 1, of the Agriculture and Markets Law of the State of New York.

# Section 3 - Local Fee for Purebred Dog Licenses

The Town Board of the Town of New Scotland establishes a local fee of \$2.30 annually for each purebred dog license issued, as permitted by Section 110, Subdivision 2, of the Agriculture and Markets Law of the State of New York.

This Local Law shall take effect upon filing with the Secretary of State.
