LOCAL LAW NO. 3 FOR 2001

A LOCAL LAW OF THE TOWN OF NEW SCOTLAND, NEW YORK, GRANTING A PARTIAL TAX EXEMPTION OF REAL PROPERTY OWNED BY GOLD STAR PARENTS TO VETERANS ALTERNATIVE PROPERTY IN ACCORDANCE WITH REAL PROPERTY TAX LAW SECTION 458-a.

BE IT ENACTED by the Town Board of the Town of New Scotland as follows:

SECTION 1. Local Law No. 3 for 2001 is entitled:

A LOCAL LAW OF THE TOWN OF NEW SCOTLAND, NEW YORK, GRANTING A PARTIAL TAX EXEMPTION OF REAL PROPERTY OWNED BY GOLD STAR PARENTS TO VETERANS ALTERNATIVE PROPERTY IN ACCORDANCE WITH REAL PROPERTY TAX LAW SECTION 458-a.

SECTION 2. Intent and Purpose.

The Town of New Scotland finds and determines that the sacrifices made by Gold Star Parents should be acknowledged by entitling them the same alternative veteran's real property tax exemptions accorded to veterans, spouses of veterans and unremarried surviving spouses of veterans, up to a maximum of 25%.

The purpose of this local law is to grant a partial tax exemption of real property owned by Gold Star Parents to Veterans Alternative Property in accordance with Real Property Tax Law Section 458-a.

SECTION 3. Gold Star Parent Definition and Eligibility.

A Gold Star Parent shall be defined as "the parent of a child who died in the line of duty while serving in the United States armed forces during a period of war". A Gold Star Parent shall be deemed to be eligible for the exemption for "qualifying residential real property".

SECTION 4. Effective Date.

This local law shall take effect January 1, 2001 and shall apply to assessment rolls prepared on the basis of a taxable status date occurring on or after such date.
